1. Chairman's Remarks

Chairman Leonard Lahtinen said a new member orientation took place prior to the committee meeting and three documents were handed out that every member should have: the Citizen Advisory Committee (CAC) Overview, the CAC By-laws, and the CAC Mission Statement. If committee members would like a copy of these documents, they were encouraged to notify Alice Rogan.

2. Assumptions and Options for the 405 Express Lanes Toll Policy and Finance Plan

Ellen Burton, External Affairs Executive Director, gave a presentation that provided insight on what the Board is thinking about in terms of the toll policy for the tolled portion of the I-405 Improvement Project (Project).

Ellen said that enforcement on the toll lanes would be accomplished through the use of both California Highway Patrol (CHP) officers and automated systems. Barry Duffin asked if OCTA knew what level of enforcement is applied on the 91 Express Lanes and if that same level of CHP enforcement would be used in this area. Ellen said OCTA has a contract with the CHP and so they are out there all the time. Barry said he drives the toll lanes in Los Angeles and sees singles on the toll lanes all the time and there appears to not be any enforcement. Ellen said she is not as familiar with the Los Angeles toll lanes but it could be that they are not funded by municipal debt so they do not get the same level of enforcement, whereas in Orange County OCTA is beholden to the bondholders and to the paying customers who are appropriately using the service.

Michael McNally suggested offering a rebate-like program to help incentivize use by more 2+ and 3 + high occupancy vehicles during peak hours. Ellen said that is something that can be looked into once the four options are thoroughly studied and OCTA has more information. For example, OCTA plans to consider a "frequent flyer" discount.

Michael asked if it was two or three spots where there would be intermediate access. Ellen said there were three. Michael asked for clarity on whether an additional lane would be provided in those intermediate access areas to transition. Ellen said she was told it would be a short transition zone, but for more clarity OCTA staff on the engineering side can come to a future meeting to talk about these transition zones and how they will work.

Vince Buck asked what percent of the toll lanes portion of the Project would be paid for by tolls. Ellen said 100 percent.

3. OC Bus Education and Marketing Program

Stella Lin, Marketing Manager, gave a presentation on the OC Bus Education and Marketing Program.

Michael McNally asked where they got the information about people who no longer ride the bus because they moved out of the area. Stella said OCTA has a database of over a thousand emails. They used this to do a system-wide survey.

A committee member asked if OCTA had programs with other companies to promote things like ride sharing and using public transportation. Stella said yes.

4. Bus Stop Spacing Efficiency Program

Chad Kim, Associate Transportation Analyst, Transit and Non-Motorized Planning, and Kyle Poff, Associate Stops and Zones Planner, Service Planning and Customer Advocacy, gave a report on the Bus Stop Spacing Efficiency Program.

Barry Duffin said staff indicated that marketing would be focused on the two pilot locations, so how will OCTA be able to determine whether the results are based upon the revisions made versus the marketing? Chad said this is OCTA's way of providing awareness to the public that this programming is going on, whereas the overall indicator would be whether or not gap speed increases. Barry asked if OCTA will be measuring both the speed of the vehicle and the increase in ridership. Alice Rogan, Public Outreach Manager, said it would be a combination of both. The point is OCTA is looking at every way to both increase efficiency and gain ridership.

Michael Stockstill asked if OCTA spoke with the coach operators for their input on this program. Staff said they polled and spoke with the coach operators at both the Santa Ana and Garden Grove base and have received valuable input. During the current public comment period, staff has also received 41 customer comment cards to date and are in the process of taking the comments into consideration and seeing what adjustments can be made.

Leonard Lahtinen asked if ridership is down on the Bravo routes. OCTA staff said no, Bravo seems to be holding steady.

5. Measure M2 Comprehensive Ten-Year Review/Proposed Amendment

Alice Rogan, Public Outreach Manager, gave a report on the Measure M2 Comprehensive Ten-Year Review and proposed amendment.

The first Measure M2 Comprehensive Ten-Year Review was recently completed. It evaluated the performance of the overall program and provided recommendations to improve performance. Although there have been legislative and economic changes, they do not warrant any significant changes to the Investment Plan (Plan).

To ensure all elements of the Plan can be delivered as promised based on the projected revenue, however, an amendment to the Plan is being proposed to close out Project T, which is complete, and reallocate the balance to Project U to cover a shortfall in the Senior and Disabled Fare Stabilization Program and Project R, which funds the ongoing operation of Metrolink service in Orange County. Alice Rogan pointed out that Project T is a capital investment project for building or improving a station, Project U is more for operations, and Project R is a mix of capital and operations.

Staff is planning to take the changes to the OCTA Board on October 26, seeking support to start the amendment process. The amendment to reallocate funds within

the transit category requires a two-thirds approval vote of OCTA Board and a two-thirds approval vote of the Taxpayer Oversight Committee.

Jeff Thompson asked if the transfer of funds would meet or mitigate the deficiencies currently projected in Project U and Project R. Alice Rogan said the \$69 million going to Project U will meet its needs and help to stabilize fares for seniors and persons with disabilities. This need was brought about by the recent recession and the change in the eligibility age from 65 to 60.

A motion was made by Jeff Thompson, seconded by Schelly Sustarsic, and passed with a majority vote to endorse OCTA staff's recommendation to amend the Measure M2 Ordinance and transfer \$69 million form Project T to Project U, and \$150 million from Project T to Project R, and send a letter to the OCTA Board of Directors notifying them of this support.
