



### Sales Tax Forecast








#### M2 Cash Balances

#### M2020 Expediting M2



- Favorable bidding climate
- Take advantage of low debt costs
- Avoid future inflation
- Deliver mobility early
- Similar to Measure M1 approach





## M2020 Freeways




- Complete or award 14 freeway projects
  - ✓ Covers 2/3 of M2 Freeway Program
- Complete environmental phase for nine remaining projects





## Freeway Projects Complete or in Construction by 2020





## Freeway Program Balance








#### M2020 Streets and Roads



- Invest nearly \$1.2 billion for streets and roads improvements
  - Deliver OC Bridges Program
  - Add roadway capacity
  - Increase capacity of intersections
  - Protect pavement conditions
- Synchronize 2,000 traffic signals across the County to ease traffic flow





## M2020 Transit



- Increase Metrolink capacity and expand frequency
- Begin construction on two Board of Directors (Board)-selected fixed guideway extensions
- Provide \$75 million for mobility choices for seniors and persons with disabilities
- Provide \$50 million for local community transit services









#### M2020 Environmental



- **Execute agreement for Conservation Plan**
- Facilitate public access as appropriate
- Create management plan and transition properties
- **Establish maintenance endowment for properties**

Allocate \$58 million in grants for water quality

improvements





## Funding and Financing



- Amended the M2 Transportation Investment Plan
  - Allocated \$709 million (portion of savings) from Project J to Project K
  - ✓ Conducted a public hearing and the Board approved the amendment on November 9, 2012
- Developed a plan of finance
  - ✓ M2 Plan of Finance was approved by the Board on November 26, 2012



#### M2 and M2020



- M2020 planned expenditures of more than \$5 billion through 2020
- Ordinance No. 3 includes specific safeguards required to ensure M2 is delivered as promised
- Coordination of projects and programs across divisions is critical



## Program Management Office (PMO)



#### **PMO Charter**

- The PMO provides unified oversight and to ensure successful delivery of M2
- The PMO monitors and reports on M2 activities and progress



#### PMO Activities



- Align M2 activities across divisions
- Ensure compliance with ordinance requirements
  - Prepare quarterly reports
  - ✓ Conduct performance assessments
  - ✓ Perform ten-year review
- Implement M2020 action plan
  - Assess organizational readiness
