Overview

The California Governor's Office of Emergency Services has conducted a review of the Orange County Transportation Authority's grant processes and documentation related to a Fiscal Year 2009-10 California Transit Security Grant Program Award No. 62610002. No findings resulted from the review.

Background

The California Governor's Office of Emergency Services (CalOES) conducted an on-site grant monitoring review covering \$2,942,887 in California Transit Security Grant Program (CTSGP) expenditures. The review was conducted in October 2013, and the results were provided in a letter dated April 25, 2014 (Attachment A).

Discussion

CalOES performed a field review for the purpose of determining whether the Orange County Transportation Authority (OCTA) complied with applicable laws, regulations, guidelines, and policies related to CTSGP funding. The CalOES grants monitor reported no findings as a result of this review.

CalOES has conducted a grant monitoring review of CTSGP funds awarded to OCTA. There were no findings resulting from this review.
