## 4. Revised OC ACCESS Riders Guide

Jack Garate, Specialized Transit Services, provided a presentation on this item.

#### Committee Member Comments:

A committee member asked about OC ACCESS statistics among Vietnamese and Korean communities and if translated versions will be provided.

Jack Garate said they started tracking language preference a year ago and they are working on providing the materials in English, Spanish, Vietnamese, Korean, Chinese Mandarin and Farsi.

A committee member asked if it would be provided in Braille and Jack Garate said yes that it is already provided along with an audio version.

A committee member asked if they have a video format and Jack Garate said they are working on it.

A committee member asked if the online Riders Guide is an editable PDF and Jack Garate said he can check.

A committee member asked for a direct link to the Riders Guide and Jack Garate said yes. He said their goal is to make the Guide as accessible as possible and OCTA appreciates the committee's feedback.

## 5. Reports

• OC Bus Update – Lupita Ibarra, Operations, presented the update. <The full presentation is available on OCTA.net.>

#### Committee Member Comments:

A committee member asked how OCTA accounts for the population density differences along routes. Lupita Ibarra said every 3 months adjustments are made based on travel patterns and overall demands.

A committee member asked for more information regarding the schedule changes. Lupita Ibarra responded there are four contractually obligated service changes per year in February, May, August and November where adjustments are made based on seasonal travel patterns and future planning efforts.

A committee member asked about the drop off and pickup options at John Wayne airport. Melissa Mungia said we are in active communication with John Wayne airport, and they are still reviewing their decision.

A committee member thanked OCTA for their communication during the strike.

• *Mobility Management Services Update* – Gracie Davis, Paratransit Services, presented the item. <The full presentation is available on OCTA.net.>

#### Committee Member Comments:

A committee member asked what would disqualify someone from using ACCESS service and Gracie Davis said if the individual can use public transportation independently and any individual who is denied receives a 100% functional assessment.

A committee member recommended using the term referral instead of denial because they are being referred to the fixed route service which gives them more flexibility. Gracie Davis said this is the terminology the Federal Transit Administration (FTA) uses.

A committee member asked about the criteria for an auto-renewal. Gracie Davis said any individual who has a medical condition that will not and cannot change within the next 5 years are granted an auto-renewal.
