

OC Bus Mobile New User Campaign – Official Rules

By participating in this promotion, you agree to the **Official Rules**.

Eligibility: To enter, you must be at least 18 years of age, or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

Timing: The Sweepstakes begins January 22 and ends February 28, 2018 at 11:59 p.m.

How to Enter: During the promotional period, download the OC Bus Mobile app, purchase and use your first bus ticket and you will automatically be entered into the contest. **Limit:** One entry per person, open to new users only.

Free 30-Day Mobile Pass Drawing: OCTA will randomly select five potential winners at the end of the promotion period from all eligible new mobile app users who have downloaded, purchased and activated a bus pass between January 22 – February 28, 2018. OCTA staff will notify the potential winners of their prize via the email address used when creating their customer profile within the OC Bus Mobile app. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within thirty (30) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Prizes must be accepted as awarded, may not be substituted, and have no cash value. 30-Day mobile passes will be automatically loaded to the winners' OC Bus Mobile account within 15 days of award acceptance. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.
