- The Bristol Street North Landscape Improvements
- The Seal Beach Boulevard Median Improvements Project

Several large projects that are currently under construction are the Edison Right-of-Way Bike Path and the 17th Street Landscaped Median.

Measure M2 Quarterly Progress Report

The board received an update on the progress of the M2 Transportation Investment Plan for the period between October and December. The report includes budget and schedule information found in the Capital Action Plan, Local Fair Share and Senior Mobility Program quarterly payments made to cities and total payments from M2 inception to December 2012.

Other highlights from the quarter include:

- The selection of Alternative 1 as the locally preferred alternative for the Interstate 405 Improvement Project.
- The first Community-Based Transit/Circulators 2013 call for projects issued on Dec. 4, for a total of \$28 million.
- The progress of the fixed-guideway projects including the Anaheim Rapid Connection Project.

Board Receives Update on Capital Action Plan Milestone

The board was presented with information regarding the progress of the Capital Action Plan for the 2012-13 second quarter. The update entailed that project delivery is making headway and 13 of the 25 planned projects have been completed.

The OCTA Capital Programs Division looks over project development and delivery of highway, rail, grade separations and facility projects. The eight key delivery milestones include:

- Begin and Complete Environmental
- Begin and Complete Design
- Construction Ready
- Advertise for Construction
- Award Contract
- Construction Complete

The milestones achieved for freeway, grade separation and rail projects include:

- Freeway Projects: The contract for construction of the M2 State Route 91 westbound widening from State Route 57 to Interstate 5 was advertised by Caltrans.
- Grade Separation Projects: Final design was completed on the Raymond Avenue railroad grade separation project, led by the city of Fullerton.

• Rail and Station Projects: The contract for construction for the San Clemente beach trail railroad crossing safety enhancement project was advertised.
