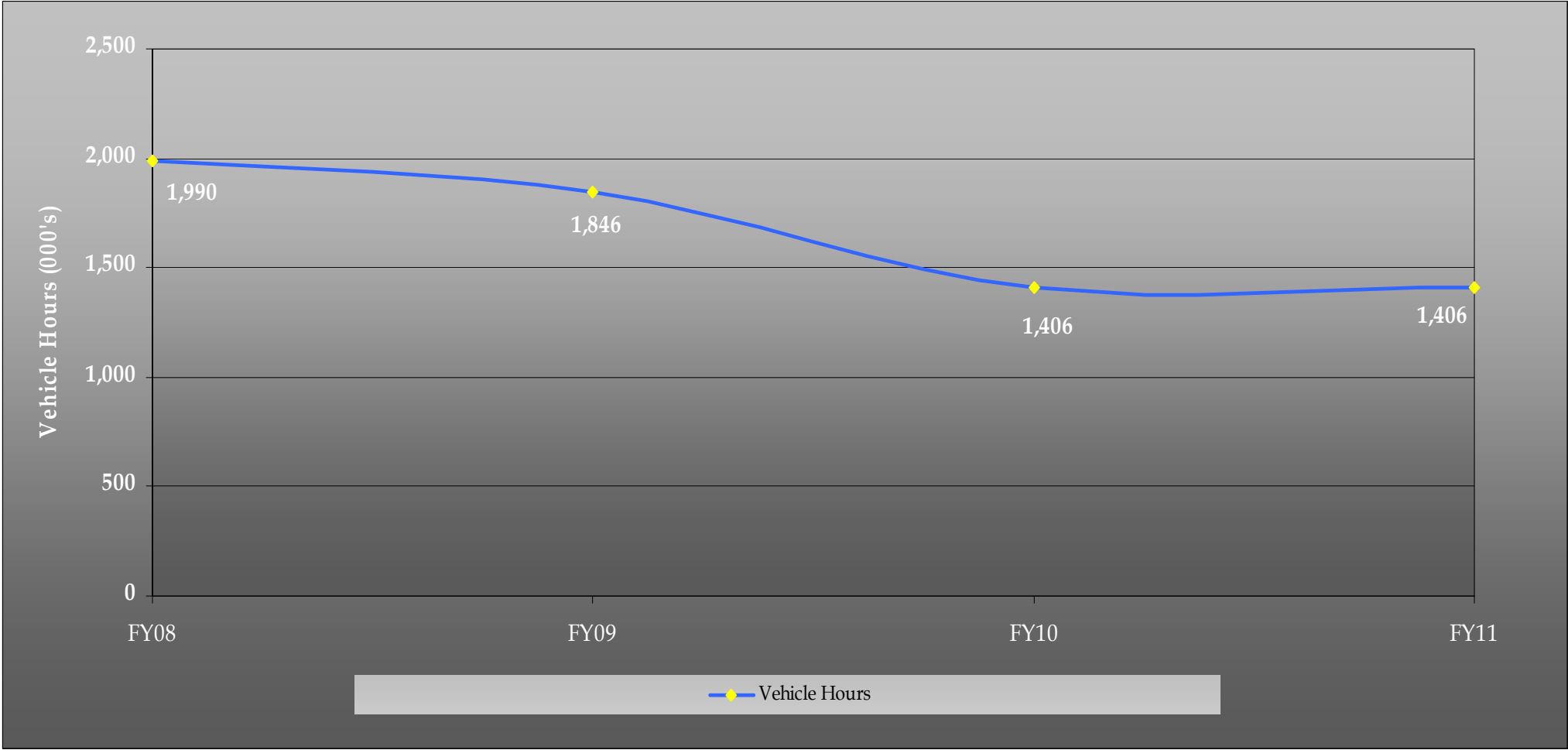
# Baseline Scenario: Revenue Assumptions

- Local Transportation Fund (LTF)
  - FY09 decrease of 8.0% / FY10 decrease of 4.3% / FY11 – growth of 3.1%
- State Transit Assistance Fund (STAF)
  - FY09 - \$4.2M and zero for all future years
- Fare Revenue
  - Fare increase in FY11
- Advertising
  - Approximately \$3.7M annual decrease
- Alternative Fuel Tax Credit
  - Receipt of fifty-cent per gallon fuel tax credit for CNG and LNG usage ends December 2009

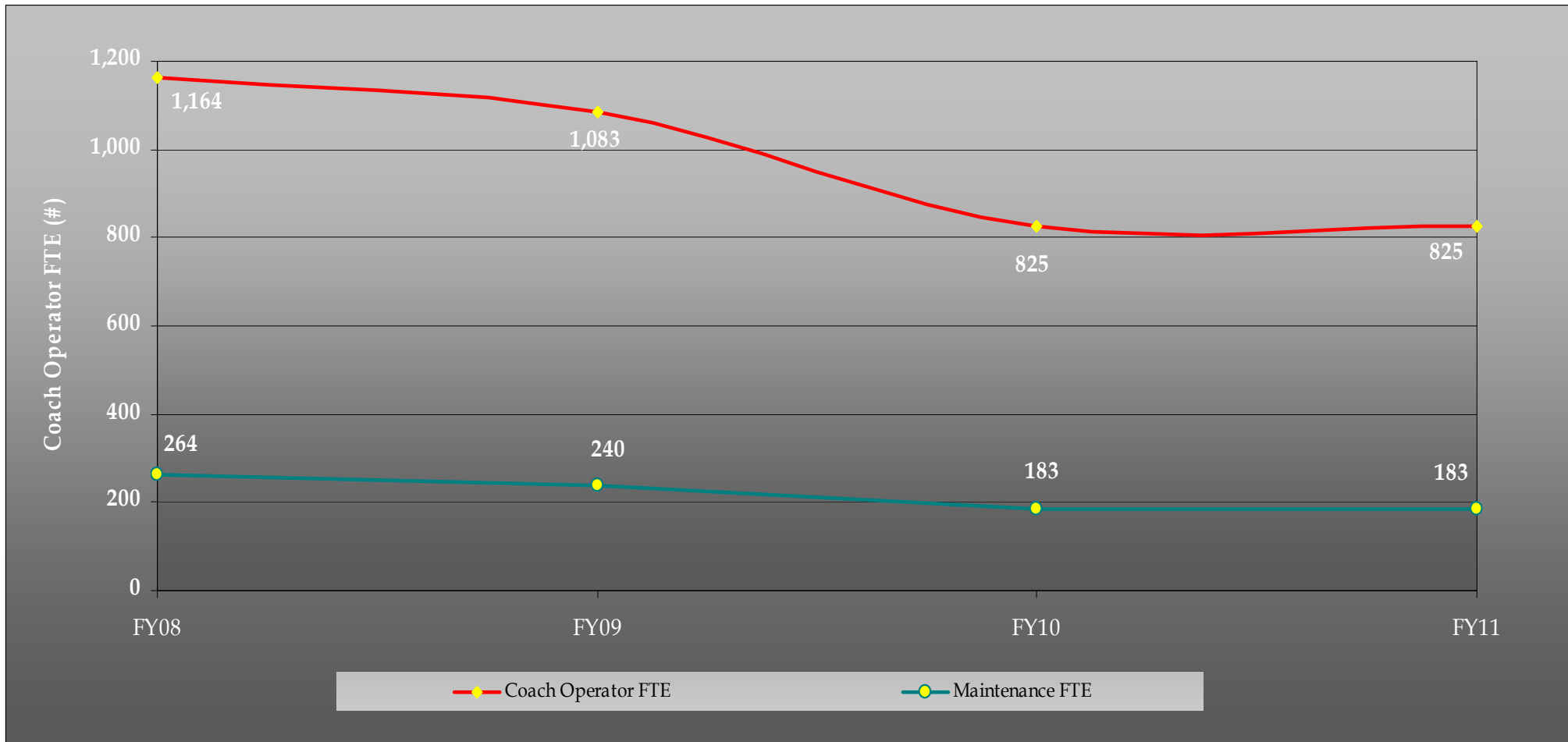
# Baseline Scenario: Vehicle Hours

# Doomsday Scenario: Revenue Assumptions

- Local Transportation Fund (LTF)
  - FY09: decrease of 8.0% / FY10: decrease of 8.0% / FY11: decrease of 5.0% / FY12: decrease of 2.0% / FY13: no growth (0.0%)
- State Transit Assistance Fund (STAF)
  - FY09 - \$4.2M and zero for all future years
- Fare Revenue
  - Fare increase in FY11
- Advertising
  - Approximately \$3.7M annual decrease
- Alternative Fuel Tax Credit
  - Receipt of fifty-cent per gallon fuel tax credit for CNG and LNG usage ends December 2009
