

## OC Bus Campaign – Official Rules

By participating in this promotion, you agree to the **Official Rules**.

**Win a 30-Day Bus Pass Drawing:** OCTA will randomly select one winner per week from all eligible Sweepstakes entries received at the time of the drawing to receive one free 30-day pass (valued at \$69). OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within fifteen (15) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.
