

New OCTA Pass Naming Feedback Sweepstakes Official Rules

OCTA staff will notify the potential winner of their prize via the email address or phone number provided to OCTA by the Sweepstakes participants. A maximum of two attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the last attempt of contact, that winner shall forfeit receipt of the prize.
