# 1. Call to Order/Welcome

Chair Wayne Heidle called the meeting to order and welcomed everyone to the Accessible Transit Advisory Committee (ATAC) meeting.

- *Pledge of Allegiance* Vice Chair Raymond Bueche led the Pledge of Allegiance.
- Approval of Minutes

A motion was made by Sue Lau, seconded by Jon Peat, to approve the July 26, 2022, Minutes and Attendance Report.

#### Committee Member Comments:

Mario Ortega requested a correction to the July 26th minutes stating they reflect that members of the public who took the survey are aware of the impact to ACCESS services when public routes are eliminated, however, committee discussion reflected that most do not know. Christina Byrne responded that the correction and modification to the minutes would be made.

A motion was made by Sue Lau to approve Mario Ortega's correction to the minutes, seconded by Jon Peat. There was one abstention.

• Welcome to New Members Chair Wayne Heidle welcomed new member Oscar Valadez.

# 2. ACCESS Driver Exceptional Service Awards

Chair Wayne Heidle said the award recipients were selected by the committee. The following ACCESS Drivers were recognized for their exceptional service:

# 3. Making Better Connections Study

Jorge Duran, Transit Planning, provided an overview on this item. The OCTA Board approved the final service plan on October 24, 2022. Responses from the public resulted in changes to the draft service plan with both additions and deletions of proposed service. Overall, there is 13% addition of trips on weekdays, 5% addition on Saturdays, and 9% addition on Sundays. Service deletions will affect fifteen currently performed daily ACCESS trips with Same-Day Taxi available as an alternative. Implementation of the plan will take up to twenty-four months and any service change updates will be provided to the committee and ACCESS riders before the changes take effect.

# Committee Member Comments:

A committee member asked if they were aware of which routes were specifically being eliminated now. Jorge Duran responded yes and Christina Byrne offered to send a communication to members with the information. A question was asked if there is a map of how many ACCESS riders in each area will no longer have an eligible home address, and if there is information about previous changes with how many riders do not have their home address in an eligible ACCESS area. A member asked how many riders are affected when a public stop is removed. Jorge Duran responded that he does not know the number from memory, but the information is available and will be shared after the meeting. Jack Garate added that users of OCTA services do not always have addresses within Orange County which can make it difficult to supply information.

A committee member inquired about the major differences between using ACCESS verses Same-Day Taxi. Jack Garate responded with similarities and differences related to cost, fare policies, trip scheduling, and subscription service.

Concern was voiced over twelve residents in South Orange County who no longer have home addresses eligible for the ACCESS subscription service, the impact, and how this is measured and factored into the route decisions. Jack Garate and Jorge Duran responded with the differing factors considered in the decisions.

# 4. Feedback on OC ACCESS Policy

Jack Garate presented the OC ACCESS Policy Changes Feedback. He said in next steps, OCTA will gather information from other transit agencies, along with the ATAC feedback, and then develop a communication plan. <The full presentation is available on OCTA.net.>

# Committee Member Comments:

A question was asked if it is considered a late cancellation on the rider if bus is an hour late. Jack Garate stated that is considered a missed trip and the violation is on the contractor side, not on the rider. A no-show is counted against the rider if a bus arrives within the 30-minute window of the scheduled trip and less than a one-hour cancellation before the scheduled trip is also counted against the rider.

An observation was made that riders ordering Same-Day Taxi pickup do not know how long their wait is and may take other transportation. Concern was expressed for the revenue loss for the taxi responding and a question was asked if a cancellation policy could be introduced. Jack Garate responded that this has been considered and will be discussed in the future. It was noted that OCTA does incur the cost of a no-show for the taxi service.

A committee member asked what a rider suspension is and how to get off suspension. Jack Garate explained the 4 tiers of suspension, timeframes, the appeal process and how they work with and inform the riders.

An inquiry was made about Same-Day Taxi and ACCESS coupons. Jack Garate said the coupons cannot be used.

# 5. Trapeze Update

Christina Blanco provided a Trapeze update. <The full presentation is available on OCTA.net.>

# Committee Member Comments:

A question was asked how volunteers will be taken for testing outbound notifications. Christina responded it will be open to community members and those using the online booking tool.

A comment was made that individuals with certain disabilities have trouble handling a phone and can functionality be made available for Google calendar/larger screens.

Melissa Mungia said they are limited with the platform functionality but she will bring it up to the software company.

A committee member added that a phone app that could link the information together with other user interfaces would provide ease of use for booking and tracking rides. Melissa said they do not have an app but their website allows online booking, cancelling and checking the ETA of an upcoming trip.

# 6. Transit Training Program

Martin Browne, Paratransit Services, provided an overview of the item. Transit Training objectives are to embed diversity, equity, inclusion and provide independence and transit options. Training is available for OC Flex, OC Access, OC Bus and Metrolink. <The full presentation is available on OCTA.net.>

# Committee Member Comments:

A committee member asked if there is a "Train the Trainer" type program. Gracie Davis, Paratransit Services responded yes, contact her for information.

# 7. OC Bus Update

Kim Tucker provided an update on ridership and on-time performance metrics. An update on the labor negotiations with the Mechanics and Service Workers Union, Teamsters Local 952, was also presented. A notification of a potential work stoppage had gone out to the public the week of October 17, 2022. This was called off and OCTA and the Union are continuing negotiations. Clarification was made that any potential work stoppage would not affect OCTA ACCESS service. <The full presentation is available on OCTA.net.>

#### Committee Member Comments:

A committee member asked about the eligibility of individuals that are specially challenged for OC ACCESS service if there is a work stoppage for OCTA buses. Gracie Davis responded that they would need to apply for the service. A follow up question was asked about what conditions the individual would be accepted under. Gracie Davis responded that it would be based upon the individual's evaluation and possibly be trip-by-trip and temporary.

A question was asked about the trial solar screens that were at the bus stops informing people of how many minutes before the bus arrival. Kim Tucker responded that the real-time signage that has been installed on Main Street, Bravo Route 553, with the October service change. There has been good feedback and options are being looked at to expand the project.

#### Committee Member Comments:

A question was asked if something can be done to have the taxis be on time for a ride reservation. Joanne Jacobson replied that the city has a contract with the cab company and has to work with them, not OCTA.

A follow-up question was asked if OCTA can have a "Train the Trainer" for the cities as they are having the same problems that OCTA riders are having with securing transportation. Joanne Jacobson replied that the cities will need to work with the contractors. A suggestion was then made by the committee member that Joanne's knowledge could be shared with city individuals on how to work with the contractors to improve the services. Joanne said she will continue to look at this request and asked for specific cities/program administrators that are reporting the issue.

• *Marketing* & *Customer Engagement* – Ryan Maloney, External Affairs, presented the item.

#### Committee Member Comments:

Confirmation if age 6 is the lowest age for the Youth Ride Free was asked. Ryan Armstrong confirmed it was, there is parental request form process in place.

An update was requested on the low-cost rider program and programs to help seniors with fixed incomes. Ryan Armstrong responded that he was not aware of a low-cost program and referred to the 2-1-1 OC program as a possible source for information for seniors.

A comment was made to use Twitter for information outreach.

• Committee Liaison Update – Christina Byrne, External Affairs, shared the next edition of the ACCESS Newsletter is being printed and should be in mailboxes within the next few weeks. Christina thanked the members for attending.
