Thoughts boy the road

If you have worked at the Orange County Transportation Authority for a while, you have probably heard of PEROW, the Pacific Electric Right of Way. Do you know the history of this 11.75-mile corridor?

This very same corridor was used by Henry Huntington for the Pacific Electric rail service between Los Angeles and Santa Ana. Opening more than 100 years ago in November 1905, the "Red Cars" offered passenger service between the Watts Junction on the Long Beach Line and downtown Santa Ana. This passenger service sparked growth in Santa Ana and Garden Grove, and played a role in the development of Stanton. The service reached its peak in 1926 and finally stopped in 1950, driven out of existence by the increasing popularity of the automobile.

With help from Measure M, the half-cent transportation sales tax approved by Orange County voters in 1990, OCTA purchased the Pacific Electric Right of Way. The purchase was made to ensure that the property was protected while being evaluated as a future rail system route. The rail corridor averages 100 feet in width and extends through the cities of La Palma, Cypress, Buena Park, Anaheim, Stanton, Garden Grove and Santa Ana. To date there are no set plans on what to do with the PEROW although there have been many suggestions over the years ranging from a transit corridor (bus or rail) to a linear park.

In 2001, OCTA began a program to enhance the corridor and improve its aesthetics. Drought-tolerant plants, along with railroad ties to highlight the property's historic significance, were incorporated into the improvements. On other portions of the land, OCTA has negotiated lease agreements for parking, nurseries or other uses. The Orange County/Los Angeles County Mobility Study currently underway by OCTA and our partners to the north includes analysis of the PEROW for a potential transit use. Obviously, whatever is ultimately decided must include input from the cities and communities the PEROW runs through. Funding of improvements is also a consideration.

The goals I established for 2008 included calling for developing a common vision for the ultimate utilization of the former Pacific Electric Right of Way. The irony that a former rail line long forgotten and unused could once again support a transportation use has not escaped us. We have begun to evaluate potential options for the corridor and are making progress toward recommending the best utilization of the right of way. All of this is part of our goal to keep Orange County Moving!

After several hours of counseling from Cesar Millan, a world-renowned dog behavior specialist and star of the National Geographic TV show, Brandenburg felt more comfortable and confident riding the bus with Beau. "It will be nice to ride the bus without all the blood, sweat and tears," Brandenburg said.

Millan successfully rehabilitated Beau by modeling "good behavior" with repetition and positive reinforcement. The Dog Whisperer said he was impressed with our bus services for members of the disability community. A special thanks to coach operator Laura Mendez, Gaile Raymer, Sarah Swensson and Ted Nguyen for setting up this special TV taping that will feature our ACCESS buses. The show will air later this summer.

# Mechanics Take 1st Place

Imagine your car's air conditioner just stopped working. Could you figure out what's wrong, describe it in writing, and fix it in 10 minutes? That's just one of the challenges that OCTA's Maintenance Team of Ernie Booe, Ray Consiglio and Anders Holst faced during the Maintenance Competition at the 2008 American Public Transportation Association (APTA) International Bus Roadeo.

Held in Austin, Texas, 47 maintenance teams from around the United States and Canada

participated in the Bus Roadeo Maintenance Competition. Working in teams of three, the transit mechanics had to diagnose and repair performance related problems using proper diagnostic and troubleshooting techniques.

The Maintenance Competition Events included: a 50-question written test, vehicle inspection with 14 defects, Detroit Diesel/ Allison power train with seven defects, Cummins/Voith power train with seven defects, truck trailer transit/Bendix air brake system (ABS) with seven defects, Thermo King HVAC IntelligAIRE with seven defects and MCI multiplex module with seven defects.

For the Thermo King test, the team had ten minutes to inspect, troubleshoot, diagnose, and legibly record the seven planted defects, as well as correct the defect that prevented the air conditioning unit from starting. Commenting on what it was

like to perform under pressure, Anders Holst said, "You just do your best to solve

the problem you've found." That's what the OCTA team did as they went on to win the Thermo King event.

The Bendix air brake event consisted of two parts with a seven minute time limit: 1) to correctly diagnose and record any or all of the ABS/Antilock system defect(s), and 2) to use a DVOM (digital volt-ohm meter to diagnose an electrical component. OCTA's team of Booe, Consiglio and Holst scored a second First Place win in this event.

OCTA's maintenance team went on to take First Place overall in the 2008 APTA International Roadeo Maintenance Competition. "After coming in Third Place for the last few years, it was nice to take First Place and get congratulated by the MTA team from Los Angeles," Ray Consiglio said.

To mark their outstanding achievement, OCTA's winning Maintenance Team received special recognition at the May 23rd Board of Directors meeting. Congratulations to Ernie Booe, Ray Consiglio and Anders Holst for their hard work and a job well done!

Flyer route for 2008. This year there will be five special OC Flyer routes on Saturdays and Sundays from convenient locations around the county directly to the Orange County Fair. The newest route, OC Flyer Route 671, will run from the Anaheim Canyon station. Anaheim residents can also catch OC Flyer Route 671 at the Lincoln Park-and-Ride. Route 671 will stop at both these locations and then take the Costa Mesa Freeway (SR-55) to the fairgrounds. This OC Flyer route is great for Metrolink riders coming to the Fair from Riverside on the Inland Empire-Orange County Line. OC Flyer fare is free with a valid Metrolink Weekends ticket.

Fairgoers coming from Los Angeles Union Station or from a station along the Metrolink Orange County Line can ride a Metrolink Weekends train to the Depot at Santa Ana and then catch OC Flyer Route 662 directly to the Fair. Metrolink riders coming from Riverside on the Inland Empire-Orange County (IEOC) Line can also ride to the Depot at Santa Ana and take OC Flyer Route 662 to the Fair. Remember to tell your customers and friends that OC Flyer fare is free with a valid Metrolink Weekends ticket.

Three additional OC Flyer routes will serve the rest of the County. North Orange County fairgoers can catch OC Flyer Route 633 at the Fullerton Park-and-Ride. For the west section of the County, OC Flyer Route 670 serves the Goldenwest Transportation Center in Huntington Beach. From South County, OC Flyer Route 691 will take passengers to the fair from the San Juan Capistrano Park-and-Ride.
