How to Enter: During the survey period, go to [OCbus.com/Connections](https://ocbus.com/connections) and complete the Feedback Questionnaire. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes.

Limit: One entry.

Drawings: OCTA will randomly select the potential winners from all eligible Sweepstakes entries. Five (5) winners will be randomly selected at the conclusion of the campaign. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A maximum of two attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the last attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Limit of one prize per participant. Each winner will receive one (1) gift card with a value of \$100. Prizes are distributed at OCTA's discretion and can be substituted at any time.
