

Bike Month 2018 Pledge Official Rules – Official Rules

Free Jax and Performance Cycle Coupon Giveaway: OCTA will send a coupon to Jax Bicycle centers and Performance Cycle shops by email to all eligible entries. OCTA staff will email the coupon to the email address provided to OCTA by the Sweepstakes participants. One prize will be awarded per eligible entry.

Drawing: OCTA will randomly select one (1) winner from all eligible Sweepstakes entries received by May 31, 2018 at 11:59 p.m. OCTA staff will notify the potential winners for their prize via the email address provided to OCTA by the participant. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within ten (10) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.
