
PUBLIC SCOPING NOTICE



WHAT'S BEING PLANNED?

The California Department of Transportation (Caltrans), in partnership with the Orange County Transportation Authority, (OCTA) proposes to modify the Interstate 5 (I-5)/EI Toro Road Interchange (PM 17.8/19.7) within the cities of Lake Forest, Laguna Woods, and Laguna Hills. The purpose of the project is to improve traffic flow, optimize traffic signalization, improve traffic mobility through adjacent local street intersections, reduce freeway ramp queuing, and apply technology to help manage traffic demand. Currently, the project is in the environmental review and preliminary engineering process. Three preliminary alternatives, including two Build Alternatives and the No Build Alternative are under consideration.

WHY THIS AD?

This notice is to inform you that Caltrans is re-initiating the environmental and engineering studies for this project. An Environmental Impact Report (EIR) and Environmental Assessment (EA) will be prepared to evaluate potential effects that could result from the proposed project. In accordance with the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA), the environmental document will be prepared as a joint environmental document. This is the Caltrans Project Approval and Environmental Document (PA&ED) phase for this Project

We are engaging in a scoping process to consider input from the public, resource agencies, and stakeholders on the depth and breadth of issues that should be addressed in the environmental document. In-person and virtual public scoping meetings will be held to inform you about the project, and to give you an opportunity to provide comments or concerns. Your comments during the scoping period will become part of the public record and will be considered in developing the environmental document and defining the project scope. A purpose and need statement for the project, preliminary alternative concepts, an overview of the environmental process, schedule, and other information will be available for viewing at these meetings.
