

OC Metrolink Summer Campaign Sweepstakes – Official Rules

By participating in this promotion, you agree to the **Official Rules**.

NO PURCHASE OR PAYMENT NECESSARY TO WIN

Eligibility: To enter, you must be at least 18 years of age or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents, and their immediate family members are not eligible.

Timing: The Sweepstakes begins on Tuesday, July 1, 2025, and ends on Sunday, August 31, 2025, at 11:59 p.m. Five winners will be selected each Monday during that period. The dates that winners will be selected are July 7, 14, 21, 28, August 4, 11, 18, 25, and September 2, 2025. Additionally, one (1) grand prize winner will be selected at the end of each campaign month (August 4 for July and September 2 for August) to receive two (2) promotional roundtrip Metrolink tickets and a \$100 gift card.

How to Enter: During the promotional period, go to MetrolinkWeekend.com and complete the Sweepstakes entry form. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes. Limit: One entry.

Drawings: OCTA will randomly select the potential winners from all eligible Sweepstakes entries received by the time of the drawings. Five (5) winners will be randomly selected each week during the campaign for a total of forty-five (45) winners, during the 9-week campaign. Additionally, one (1) winner will be randomly selected at the end of each month during the campaign for a total of two (2) winners, one winner each month for July and August for the two-month campaign. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A maximum of two attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Limit of one prize per participant. Each weekly winner will receive two (2) promotional roundtrip Metrolink tickets (valued at \$110). Each of the two (2) monthly winners will receive two (2) promotional roundtrip Metrolink tickets (valued at \$110) and a \$100 gift card (total valued at \$210). Prizes are distributed at OCTA's discretion and can be substituted at any time.

Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.
