

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) District 12, in cooperation with the Orange County Transportation Authority (OCTA), is studying proposed improvements to State Route 55 (SR-55) between Interstate 5 (I-5) and State Route 91 (SR-91), Post Mile (PM) 10.4 to R17.9, in the cities of Anaheim, Orange, Tustin and Santa Ana in Orange County. The purpose of the proposed project is to reduce congestion, improve mobility, increase freeway capacity and improve traffic operations.

The alternatives under consideration are "Alternative 1" (No Build Alternative) and "Alternative 2" (additional general-purpose lanes and ramp modifications).

WHY THIS AD?

Caltrans has studied the effects this project may have on the environment. Our studies show this project will not significantly affect the quality of the environment. The report that explains this is called an Initial Study/Environmental Assessment (IS/EA). This notice tells you of the availability of the draft IS/EA with a proposed Negative Declaration (ND). A public hearing (open house format) will be held to give you an opportunity to learn about the proposed project and potential impacts before an alternative is recommended and approved.
