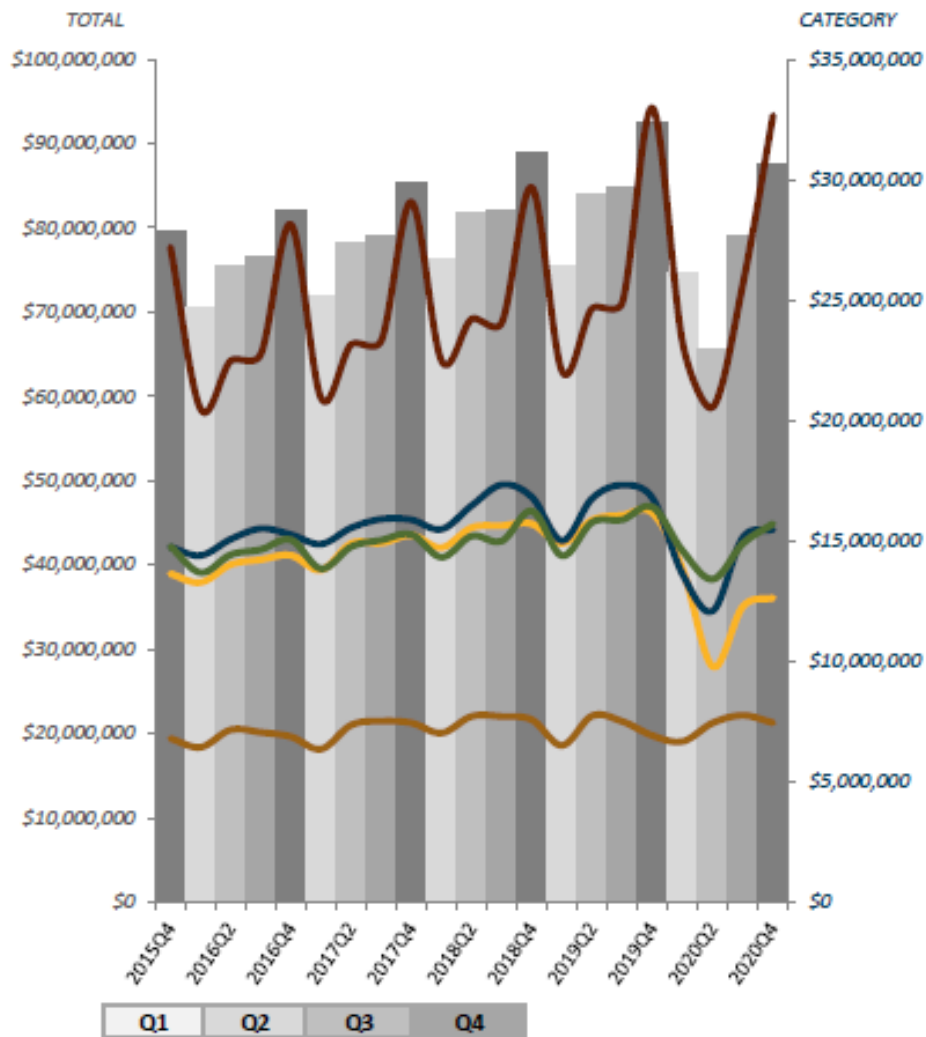

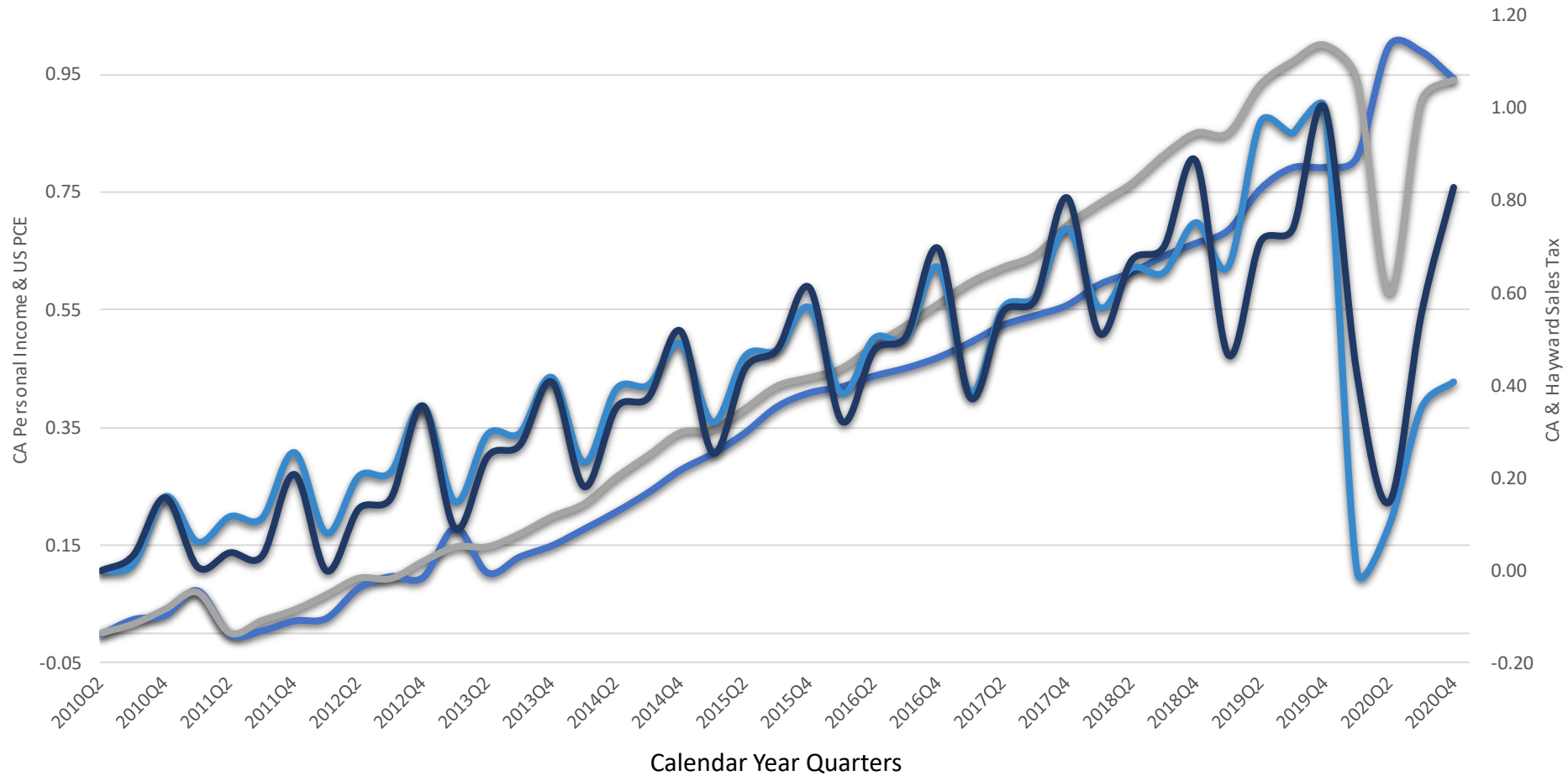

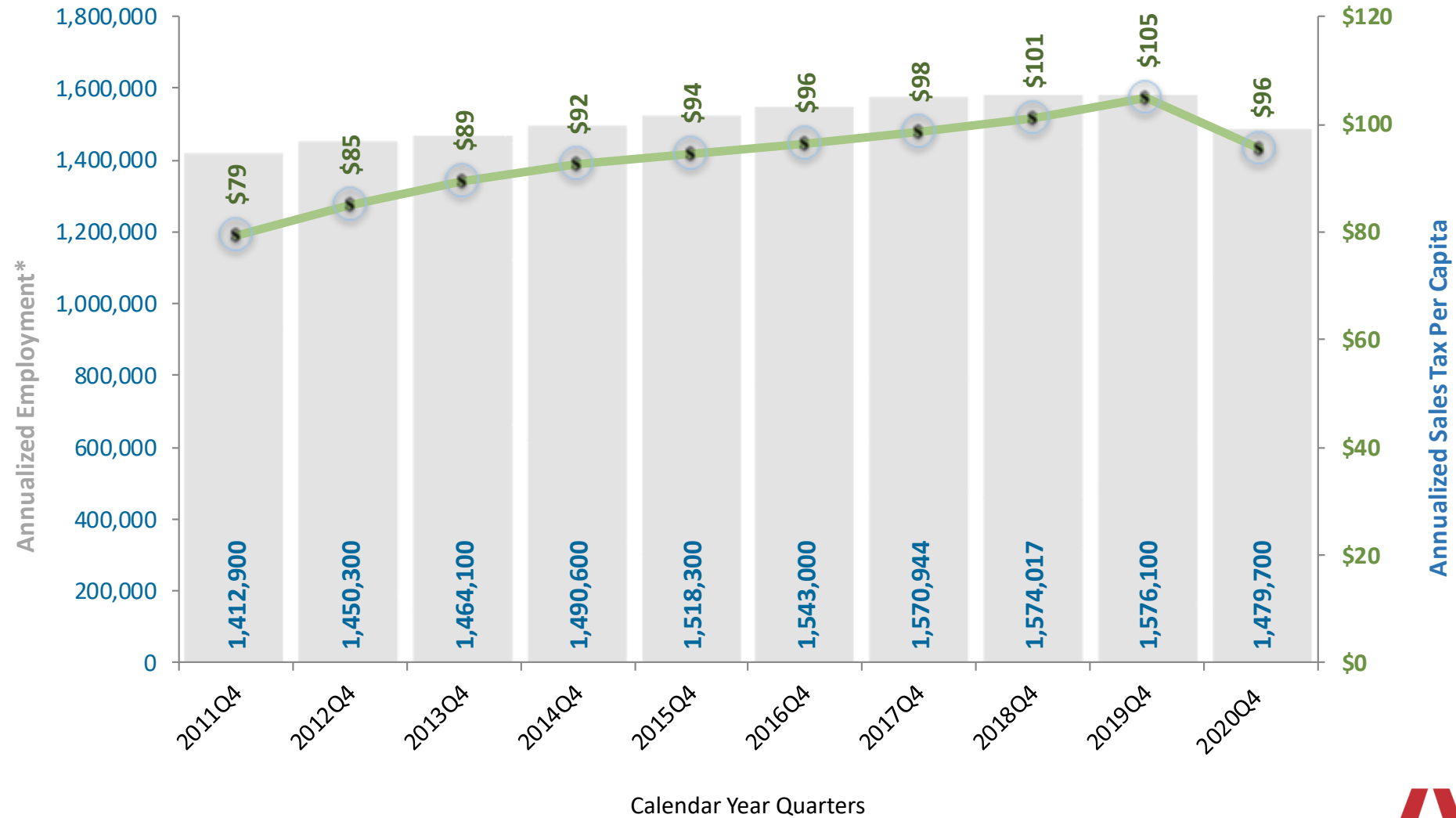
# Sales Tax Revenues Compared to Income

## What Have We Learned?

- Pandemic recession is unique with unique impacts
- Primary declines have been in restaurants, gas stations, and 'traditional' retail (malls & main street)
- Internet spending has offset much of the decline in retail
- New Wayfair revenues from out of state internet sales also were a major offset to sales tax declines
- Employment losses concentrated in low wage sectors such as hospitality and service sectors



# Forecast Assumptions

- Vaccine distribution will continue with vaccines available for all who want them in California by Summer 2021
- California business restrictions tiering system will end by June 30 and consumers will adjust to the 'new normal'
- Another re-sheltering/business tier regulations period will not take place in Fall/Winter 2021
- Federal Stimulus and Monetary policies helped overall economic health and will help avoid a longer and/or deeper recession

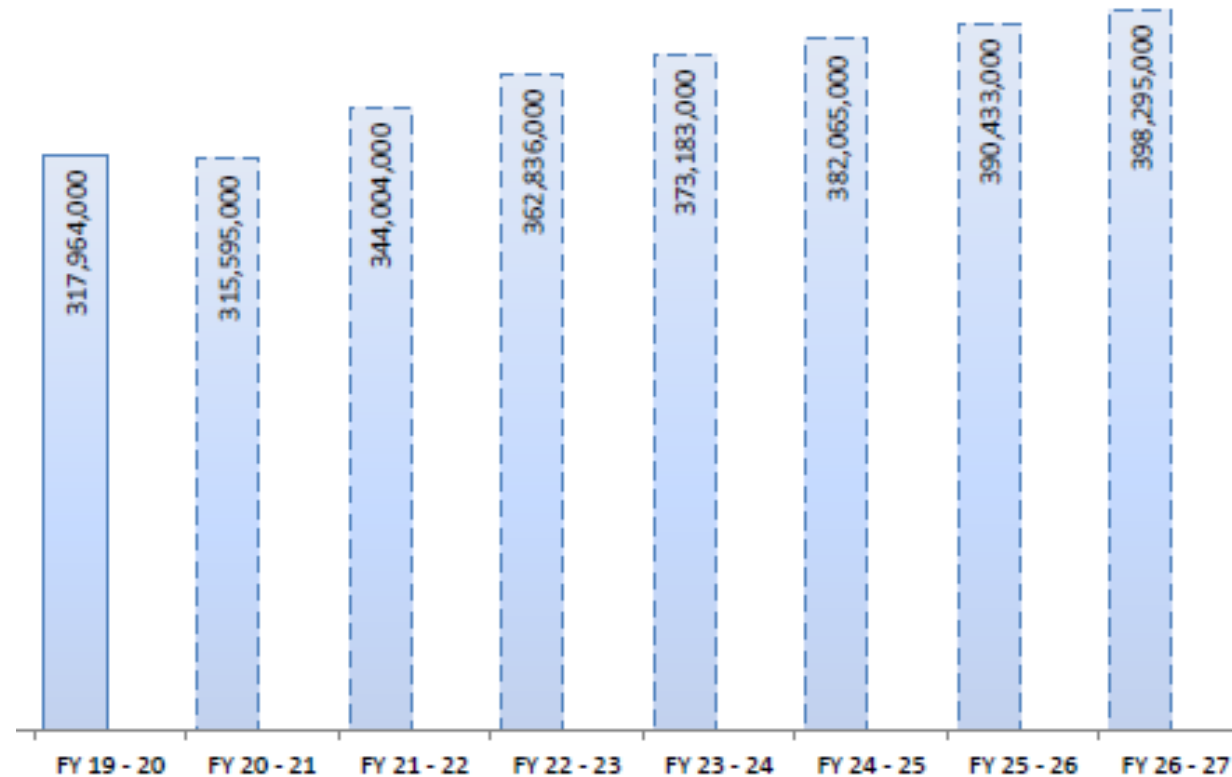
# Recovery Forecast Assumptions

## Sales Tax Forecast Recovery Assumptions

- Pent up demand & record levels of savings, will increase consumer consumption & a rebound in sales tax in FY 21/22
- Work from home will gradually ease in 2021 & 2022, domestic travel will return by 2022, business and convention by 2023, and international travel will return in 2024.
- While inflation is a potential brake to future economic growth, there is a lack of consensus of the threat, and it is likely several years off due to lingering unemployment.
- Virus variants, while a potential threat, are managed through current vaccination program.

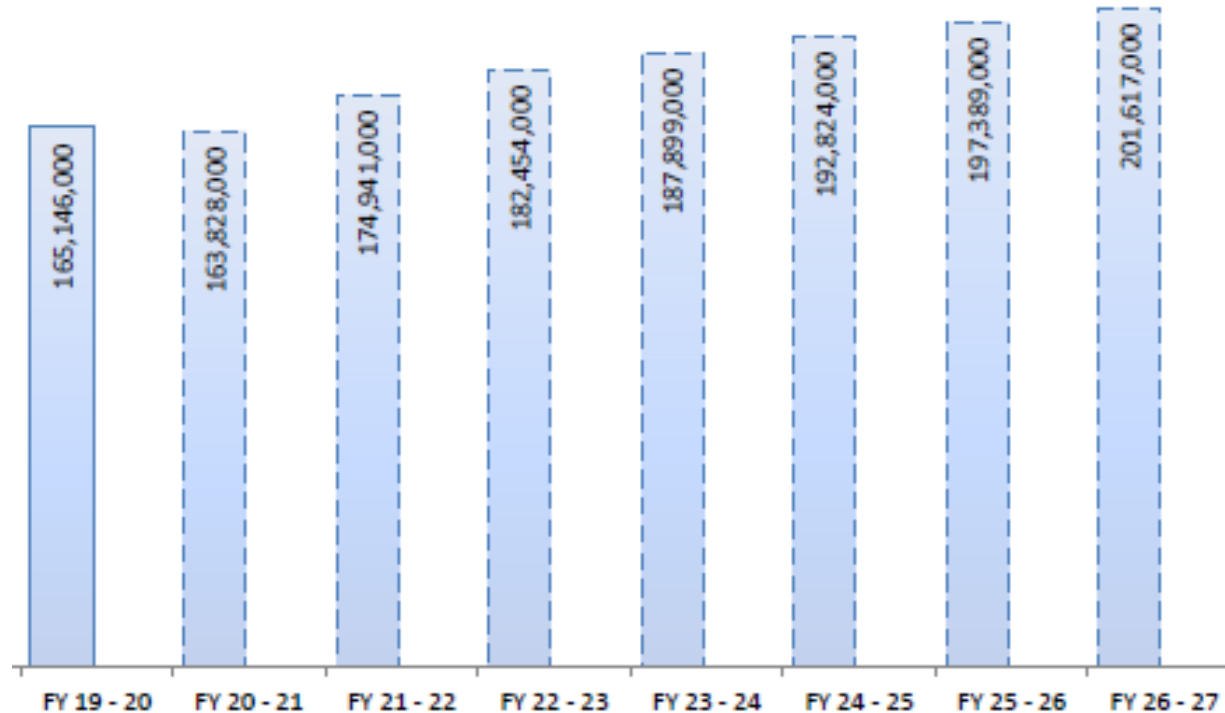
