

IIJA Funding Overview






CA Highway and Transit Funding



- Increases formula transit funding by:
 - \$620 million annually
 - \$3.1 billion over five years
- Increases formula highway funding by:
 - \$1.7 billion annually
 - \$8.5 billion over five years
