

## **OC Transportation Demand Management Survey Sweepstakes Official Rules**

A maximum of two (2) attempts will be made to contact each winner using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the last attempt of contact, that winner shall forfeit receipt of the prize.

**Prizes:** Limit of one (1) prize per person. Each winner will receive one (1) gift card with a value of \$50. Prizes are distributed at OCTA's discretion and can be substituted at any time. Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.
