Board Member Hack reported on the closure of the San Onofre Nuclear Generating Station (SONGS) and commented that the Nuclear Regulatory Commission is looking into whether the plant should re-open or not.

Board Member Glaab commented that the Southern California Edison is reviewing how to bring SONGS back on-line in a safe manner.

Background: Five current Orange County Council of Governments (OCCOG) Board

members are terming out of their respective council seats in December 2012, four Southern California Association of Governments (SCAG) District Representatives and one Orange County Sanitation District representative. For the District seats, staff recommends notifying cities within these Districts to alert them to these vacancies and to seek potential candidates beginning in December. Per OCCOG bylaws, SCAG election guidelines will be followed to fill these vacancies. For the Orange County Sanitation District (OCSD) representative, staff will work with OCSD staff to identify a potential representative. It is anticipated that elections will occur at the January 2013 OCCOG Board meeting.

Staff also recommends filling vacancies on the OCCOG Board for three non-voting, ex-officio positions. Kate Klimow, Assistant Vice Chancellor, Community and Government Relations from the University of California, Irvine has submitted her name for the University Representative. Bryan Starr, Senior Vice President of Government Relations with the Orange County Business Council has submitted his name for consideration for the Board's Business Community Representative. Lastly, Steve Schuyler, Vice President of Government Affairs for the Building Industry Association of Southern California and currently the Private Sector Representative Alternate member is recommended to fill this seat as the primary member. Background: September 30, 2012, was the deadline for Governor Brown to sign or veto

any legislation that made it to his desk during the legislative session. This year the Governor signed a total of 876 bills, and 120 were vetoed. Overall, the Governor had a veto rate of about 12 percent. Any bills signed this session will become effective January 1, 2013, unless designated as an urgency bill. Bills that did not meet applicable deadlines are no longer

available for consideration, unless reintroduced next session.





Comments of the Draft 2012 Air Quality Management

Plan and Notice of Preparation

Dear Dr. Wallerstein:

The Orange County Council of Governments (OCCOG) welcomes its responsibility to comment on the Draft 2012 Air Quality Management Plan (AQMP) and Notice of Preparation (NOP). Additionally, efforts to reach out to Orange County local jurisdictions and stakeholders by the South Coast Air Quality Management District (AQMD) staff and yourself have been well received.

Given the timing of the 2012 AQMP comment period, the comments below have not been considered by the full OCCOG Board of Directors. The OCCOG Technical Advisory Committee and an ad-hoc group of local jurisdiction have reviewed the draft and their input is included below. We have also collaborated on further review with other stakeholders such as the Association of California Cities-Orange County. I believe these preliminary comments to be a reflective consensus review of OCCOG's 39 member agencies based on what we know to date. As additional information related to the AQMP is released, we may have additional comments.

 OCCOG is concerned that some required documentation related to the AQMP is, as of the writing of this letter, still not available for review. Specifically the socio-economic report has yet to be released. This document is crucial for local jurisdictions to review. OCCOG requests that all AQMP support documents be released as soon as possible and that the public comment period be extended an additional 45-days to allow for required review and comment. While it is unclear as to when comments are officially due, we have by AQMD staff that comments August 31, 2012 will be responded to. OCCOG desires to have a response to our comments.

- 2. The draft 2012 AQMP is required to address PM 2.5, not ozone, yet ozone is addressed throughout the draft 2012 AQMP. This is distractive to the primary review. It is recommended that the references to ozone and the proposed control measures to address ozone be postponed for further discussion of the 2015 AQMP.
- Should the AQMP continue to include references to ozone and control measures, we strongly suggest that they are included in an appendix to the document and not in the AQMP itself. Further, OCCOG requests that it be clearly stated throughout the document and in any adopting resolution that the ozone control measures are strictly VOLUNTARY.
- 4. OCCOG is also interested in how ozone control measures will be addressed in the Draft Environmental Impact Report (DEIR). Since the ozone control measures are voluntary, they should not be included as mitigation measures in the DEIR but should be referenced in an appendix as Best Management Practices that can be voluntarily implemented.

Again, OCCOG appreciates the opportunity to provide preliminary comments on the 2012 AQMP and NOP. We look forward to working with AQMD on a final plan that balances environmental stewardship with the need for projects and programs needed to keep Orange County moving forward. We look forward to receiving your response to our comments.

Dear Dr. Wallerstein:

The Orange County Council of Governments (OCCOG) welcomes its responsibility to comment on the Draft 2012 Air Quality Management Plan Program Environmental Impact Report (AQMP/PEIR). As you will recall, OCCOG shared comments on the Draft 2012 Air Quality Management Plan in our August 31, 2012 letter to you.

As with our previous comment letter, given the timing of the comment period, the comments below have not been considered by the full OCCOG Board of Directors. The OCCOG Technical Advisory Committee has formed an ad-hoc subcommittee to review AQMP documents and their input formed the basis of our comments.

- PEIR Appendix F: "RTP/SCS Mitigation Measures Table". The appendix title page should be revised to reflect the more accurate title "Examples of Measures That Could Reduce Impacts from Planning, Development, and needed change will make the document consistent with the adopted Southern California Association of Governments 2012-2035 Regional Transportation Plan/Sustainable Communities Strategy.
- 2. It appears that the demographic and socio-economic data included in the analysis of the PEIR is outdated and is not the most recent data prepared for the Center for Demographic Research and used in the Orange County Sustainable Communities Strategy and the Southern California Association of Governments 2012-2035 Regional Transportation Plan/Sustainable Communities Strategy. The analysis should be revised to include the demographic and socio-economic data contained in the Orange County Sustainable Communities Strategy.

> 3. There are significant errors in describing Orange County in Subchapter 3.6 – Land Use and Planning and Subchapter 3.2 – Climate Change. Corrections need to be made in the final draft of the PEIR. These errors are included as an attachment to this letter.

Again, OCCOG appreciates the opportunity to provide further comments on the 2012 AQMP/PEIR. At this time, we anticipate providing further comment on the overall AQMP plan and the recently released socio-economic report.

We look forward to receiving your response to our comments and would be pleased to work with your staff on the noted technical corrections.

Errors Noted Orange County Data in Subchapters 3.6 and 3.2 Land Use and Planning and Climate Change

<u>Subsection 3.6.3.2 Orange County (page 3.6-7):</u> The Orange County General Plan is only applicable to areas of unincorporated Orange County and does not supersede the General Plans of the 34 independent local jurisdictions. Therefore, it is erroneous and misleading to state policies identified in the County of Orange General Plan and generalize that these policies are applicable to the 34 local Orange County jurisdictions. The PEIR should either be revised to clearly state that the County of Orange General Plan is only applicable to those unincorporated areas of the County of Orange and each local jurisdiction has their own governing General Plan or remove the text in its entirety.

<u>Subsection 3.6.3.2.2 Commercial (page 3.6-8):</u> There are errors in describing the commercial areas within Orange County that need to be revised in the final version of the Program Environmental Impact Report.

1) The commercial area located within close proximity to the intersection of Interstate 5, State Route 22, and State Route 57 is <u>not</u> known as the "Orange Crush" as noted in the draft PEIR. The "Orange Crush" is used to describe the intersection of the three transportation corridors, <u>not</u> the commercial/office area. 2) The area surrounding John Wayne Airport and the University of California, Irvine is known as the Irvine Business Complex or IBC <u>not</u> the Irvine Spectrum. 3) The terminology "El Toro Y" is used to describe the intersection of two transportation corridors, Interstate 405 and Interstate 5, <u>not</u> the commercial/office center. That is the Irvine Spectrum.

<u>Subsection 3.6.3.2.3 Industrial (page 3.6-8):</u> The paragraph is erroneous in referencing the Orange County General Plan, which is only applicable to the unincorporated areas of the County of Orange. Every local jurisdiction has their own governing General Plan that may identify areas of industrial use. The paragraph needs to be revised for the final PEIR.

<u>Subsection 3.6.3.2.5 Open Space (page 3.6-8):</u> The Orange County Sustainable Communities Strategy identifies the preservation/open space programs located throughout all of Orange County, including the individual efforts of the County of Orange and the 34 local jurisdictions. This paragraph should be revised to generally reflect the open space policies outlined in the Orange County Sustainable Communities Strategy.

Table 3.2-1A and Table 3.2-1B (pages 3.2-13 and 3.2-14): It is unclear how certain calculations were made in both tables due to the rounding of the values. The Final PEIR should include the non-rounded values to ensure reviewers are able to confirm the calculations and assumptions. In addition, any reference to these numbers in the text of the document should be corrected for consistency. For example on Table 3.2-1A, under Waste Disposal NOx, the 2007 AQMP value is 2 and the draft 2012 AQMP is 2, yet the percent change is calculated at -24%. In Table 3.2-1B, under Fuel Consumption Sox, the 2007 AQMP value is 2 and the draft 2012 AQMP value is 2, yet the percent change is -3%. The Petroleum Production and Marketing Sox 2007 AQMP value is 1 and the draft 2012 AQMP value is 1, yet the percent change is -32%. The Petroleum Production and Marketing PM 2.5 2007 AQMP value is 1 and the draft 2012 AQMP value is 2, yet the percent change is 68%. The Cleaning and Surface Coatings PM 2 5 2007 AQMP value is 1 and the draft 2012 AQMP value is 2, yet the percent change is 53%.

Southern California Association of Governments (SCAG) began meeting in late September, 2012. Since that time, a total of twelve subcommittee meetings have taken place. As has been reported, several Board members participate on these subcommittees and the Technical Advisory Committee has also attended these meetings. Attachments A and B, compiled by

SCAG staff, outline broadly the status of these committees.

Staff and Board Members who participate on these subcommittees will offer observations to date. The subcommittees are expected to meet through

February 2013.

Transportation Subcommittees Status

October 23, 2012

Goods Movement Subcommittee

1st Meeting, September 24, 2012

Discussion focused on the specific strategies included in the 2012-2035 RTP/SCS, including an initial review of goods movement markets—particularly focused on intra-regional truck movements or truck origins/distributions within the region. Discussion also highlighted SCAG's recently completed Border Crossing Study. Staff discussed the magnitude and importance of the international land border crossings in Imperial County—focused on the data collection work completed for the study, including targeted stakeholder surveys and truck intercept surveys. This first meeting was intended to provide an overview of the goods movement related work accomplished to date by SCAG. The committee also reviewed and approved the proposed subcommittee work plan.

Proposed 2nd Meeting, October 29, 2012

This meeting will continue to highlight key issues with market segmentation of goods movement. Cambridge Systematics will provide this overview and further discuss the economics of goods movement. Staff also anticipates a presentation from John Husing, focusing on "International Trade and Economic Development." Additionally, the meeting will highlight the importance of warehouse distribution activities. BJ Patterson, CEO of Pacific Mountain Logistics, will discuss warehousing operation challenges. The focus of this meeting is to highlight the various goods movement markets, and in particular emphasize the workforce/economic development potential associated with industrial development. There's been considerable concerns about warehousing development potential in the region as SCAG's latest studies indicate that by the horizon year of our RTP/SCS, we'll face a shortage of warehousing space. This initial discussion is intended to better understand the warehousing industry in particular, and consider future analyses and direction to facilitate industrial development and workforce related issues.

Transportation Finance Subcommittee

1st Meeting, October 12, 2012

Discussion focused on an overview of the financial context and strategies incorporated into the 2012-2035 RTP/SCS. Staff reviewed key assumptions about general inflation, the construction cost index, and various economic drivers that impact fundamental assumptions for SCAG's financial forecasting. Staff also reviewed the key revenue strategies and discussed potential next steps related to some of these options. Additionally, Susan Bransen, Deputy Director of the California Transportation Commission (CTC), provided an update on the Statewide Ten-Year Needs Assessment, including a discussion of the projected shortfall and potential funding options being considered for a final report to the Commission. Finally, Cosette Stark, of Los Angeles Metro, briefly spoke on the significance of the Measure J initiative. The subcommittee had a lively discussion about the various funding opportunities and cost efficiency measures. The subcommittee reviewed and approved the proposed work plan.

Proposed 2nd Meeting – Date TBD

Staff anticipates convening the second subcommittee on November 16th (although we are still trying to confirm this date). This meeting will continue to highlight key components of SCAG's financial forecasting—particularly focusing in on the cost side of the equation per subcommittee membership concerns. Staff anticipates a more thorough review of cost considerations including components of material and labor costs, trends and economic implications. Additionally, presentations and discussion will focus on expediting project delivery. Staff anticipates a presentation from SCAG's economic consultants—providing a preview of their economic impact assessment for project acceleration. Also, SCAG anticipates participation from Caltrans' HQ economic division to discuss California's construction cost trends and indices.

High-Speed Rail & Transit Subcommittee

1st Meeting, October 5, 2012

The meeting was well-attended by subcommittee members and also included representatives from our sister agencies including XPressWest, Caltrans and the California High-Speed Rail Authority. First the chair, Karen Spiegel, went over the purpose and objectives of the subcommittee and its role. Next, Philip Law, Acting Manager of Transit/Rail, described the Subcommittee's Work Plan and Deliverables. The work plan and deliverables were unanimously approved by the subcommittee.

Next, three presentations were made for informational purposes and included: 1) a regional rail update by Steve Fox, 2) an overview of MAP-21 by Jeff Dunn, with particular emphasis on transit and rail, and 3) an update on Measure J by David Yale, Executive Officer at Metro. There was a good level of discussion of the information items by subcommittee members.

Proposed 2nd Meeting, November 9, 2012

This meeting places its emphasis on rail. Presentations include: 1) an update on the Southern California MOU by Don Sepulveda, Executive Officer for Rail at Metro, with particular emphasis on next steps, 2) an update on the MOU from the California High-Speed Rail Authority's perspective by CHSRA (either Jeff Morales, CEO, or Michelle Boehm, Southern California Regional Director), 3) an update on Amtrak's Northeast Corridor Visioning Plan by Amtrak staff, 4) an update on RCTC's rail planning and implementation efforts by Sheldon Peterson, Rail Manager, and 5) an update on the LOSSAN Strategic Implementation Plan by Linda Bohlinger, HNTB and Linda Culp, Rail Manager at SANDAG.

Active Transportation, Public Health, & Sustainability Subcommittees Status

October 24, 2012

Active Transportation Subcommittee

1st Meeting, September 24, 2012

Discussion focused on a review of the Active Transportation Work Plan for the years 2012-2016. The Work Plan is open for review and comment through the end of the year and was presented to the Transportation Committee at their October 4th meeting. Other presentations included the Orange County Fourth Supervisory District Strategic Bikeway Plan followed by the Long Beach Active Transportation Implementation. The first meeting was intended to provide an overview of the Active Transportation work currently being done at SCAG and how it ties into local efforts at both the county and city levels. The subcommittee also reviewed and approved the proposed subcommittee meeting outlook.

Proposed 2nd Meeting, November 5, 2012

This meeting is a planned joint meeting of the three subcommittees: Active Transportation, Public Health, and Sustainability. At this meeting staff will introduce policy frameworks that have been developed for each subcommittee. Each framework will highlight the following policy components: definitions, needs assessment, performance measurement, strategy, and investment. Staff will elaborate on the role of subcommittees in the development of the 2016 RTP/SCS. The meeting will also feature guest speakers from the Los Angeles Department of Transportation, the City of Anaheim, the San Bernardino County Department of Public Health, and the Coachella Valley Association of Governments. Guest speakers will present local projects and programs that promote active transportation, public health, and sustainability principles, and show the interrelated character of all three areas.

Public Health Subcommittee

1st Meeting, October 1, 2012

Discussion focused on preliminary public health framework and performance measures included in the 2012–2035 RTP/SCS, including a review of technical and data limitations. Staff discussed other public health outcomes of interest and the inclusion of other health determinants in the 2016 RTP/SCS, including access to active transportation options, housing affordability, access to open space, and public safety. Staff also presented new scenario

planning tools that are under development, which may provide potential public health outputs that can be used in the 2016 RTP/SCS. Additionally, staff provided an update on the status of an application for a public health grant offered by the Robert Wood Johnson Foundation and Pew Charitable Trust. The grant proposal concept will assess the broader health impacts of High-Quality Transit Area (HQTA) communities in the SCAG region. The first meeting was intended to provide an overview of the public health related work currently being done at SCAG. The subcommittee also reviewed and approved the proposed subcommittee meeting outlook.

Proposed 2nd Meeting, November 5, 2012

Sustainability Subcommittee

1st Meeting, October 1, 2012

The first meeting was intended to provide an overview of the analytical tools available to prepare development scenarios for the 2016 RTP/SCS. Peter Calthorpe presented a case study of one such software system called Urban Footprint. SCAG staff presented an overview of the 2016 RTP/SCS development process, which will cover the next three and half years. Discussion focused on the availability of any tools and processes to local officials, as well continuing the successful relationship established between SCAG and local cities during the development of the 2012 RTP/SCS. Additionally, there was some discussion about the difference between large lot and small lot single family homes and their applicability to different urban contexts. Some discussion focused on the need to revive tools like redevelopment which will allow local cities to fill the financing gap between desired development and market supported development.

BACKGROUND

One year after public safety realignment went into effect on October 1, 2011, law enforcement and public safety officials from the six Southern California counties met on October 4, 2012 with the 84-member governing board of the Southern California Association of Governments (SCAG) Regional Council to discuss the impact of the transfer of low-level state prisoners to the counties' jail and probation system. Public safety officials such as Sheriffs, Police Department officials, Probation Officers along with representatives from county District Attorney's offices from Imperial, Los Angeles, Orange, Riverside, San Bernardino, and Ventura counties all spoke about how AB 109 is impacting their counties and departments.

The enacted legislation contains numerous statutory and technical changes to implement changes to the Budget Act of 2011. The bill expands the authority of local correctional administrators to use alternative custody methods for low level/non-violent offenders, and establishes day for day credit for offenders serving time in jail.

The discussion revolved around five common areas:

- ► NO DEDICATED FUNDING
- ► INSUFFICIENT JAIL SPACE/FACILITIES
- ► ISSUES POST-RELEASE & RECIDIVISM
- ➢ ADVERSE EFFECTS TO PUBLIC SAFETY
- ► PROBATION HAS THE MOST RESPONSIBILITY AND INADEQUATE RESOURCES

In addition, concerns were raised regarding the legal challenges that the counties could potentially face.

NO DEDICATED FUNDING

Imperial

Protect funding sources established thus far. Counties cannot afford to bear the burden of public safely without a dependable funding source.

Los Angeles

Currently, over 1,000 beds remain unused due to lack of funding.

Orange

- > A constitutional amendment is needed to guarantee funding. Long-term healthcare costs (e.g., dialysis and other medications) that inmates require are increasing.
- Dedicated funds to have local law enforcement help with supervision by performing compliance checks and letting the offenders know local law enforcement and probation are keeping a close watch.

Riverside

Significant resources are needed and there is a serious concern for funding allocation being sufficient in years to come because of an inadequate funding stream.

San Bernardino

- > There is concern about revenue stream that hampers long-term financial planning.
- Guaranteed funding is needed because decreases will make all programs ineffective.

Ventura

- Funding is needed to not only identify the true cost of adding to the County's existing workload, but to make sure the state understands the need for adequate and secure funding.
- > Set aside funding for four of the largest County agencies to contract more officers to work in conjunction with Probation to provide supervision teams.
- Realignment dollars are needed because of issues happening in households of offenders. There should be an effort to target homes exposed to drug addicted offenders to reach children in those homes. The focus should not be solely on inmates.

INSUFFICIENT JAIL SPACE/FACILITIES

Imperial

Rising jail population with length of stay for offender is much longer (up to 16 years).

Los Angeles

Los Angeles County is currently facing a shortage of female bedspace. To make room, the County has lowered out female misdemeanant sentences to a flat 10% of the actual sentence. Female facility capacity is 2,380 and there are 2,471 women in custody at this time (October 2012). With the loss of the ICE Contract, Los Angeles County is faced with the loss of several million dollars in revenue and an overage of

- personnel, coupled with the inability to re-open those lost contracted beds due to fiscal cuts.
- > Los Angeles County has the largest re-aligned population of inmates in the State and the County's portion is growing by just over 100 non-serious, non-violent, non-sexual offenders (N3s) per month.
- When realignment started, the Los Angeles County jail population was at 15,400 inmates. Today it is over 19,000, and 5,738 of them are N3s. This means that approximately one-third of the inmates now in County jail would have gone to prison if not for realignment.

Orange

Prisoners are an additional burden because of a Federal regulatory population cap of 7,000 prisoners. Current population is at 6,500 and growing. Required segregation is becoming an issue with space running out.

Riverside

- > 188 individuals were sentenced to three years or more. County jail was not designed to handle long-term sentences.
- > Riverside County is dealing with overcrowding at a much greater extent. They have attempted to implement other programs (e.g., work release) and tried to expand, but jails were at 87% capacity in October 2011. The County now has no choice but to pick the best of the worst and release them early because of Federal capacity regulations.
- > County has had to do early releases more than 5,200 times because of a lack of jail space. Since January 2012, this issue shows no signs of slowing down.

San Bernardino

- Substantially higher population well above what the state estimated.
- > A legislative fix is needed to put a cap on the number of years these offenders can spend in the facility.

Ventura

- > 73% of N3s have been jail-only sentences and local jails are filling up.
- Ventura County had more flexibility with housing, but that has evaporated since October 2011. N3s are 16% of population and have exceeded regular capacity. There has been a considerable jump in assaults and fights, and inmate conflicts have doubled in since July 2012.
- Based on states numbers, the County will soon reach maximum capacity and will not be able to accept any more prisoners.

ISSUES WITH POST-RELEASE & RECIDIVISM

Imperial

Challenges of realignment places large burden on various evidence-based programs (e.g., pre-trial services, day reporting centers, etc.) that could prevent recidivism.

Los Angeles

- > The Sheriff's Department is currently providing treatment, but once released, the "supervision tail" is gone and the offenders begin to commit crimes again.
- > There is no safety net in place for those individuals that are released. Trying to lower recidivism rates of these offenders by assigning 150 officers to assessing their background, compliance checks, and drug tests.
- In Gardena, only 15% of N3s actually live where they say they live, but the remainder never check in and use someone else's address. Agencies now have to commit more resources to find these individuals.

Orange

- > Some offenders have become successful at staying away from crime using day reporting centers. This only works for those out of custody that are trying to transition into the community. The problem is that few want the service (i.e., no incentive to complete day center program).
- ➤ Need for the out of custody treatment side of AB 109. 60% of reoffenders have had drug offense in their new violation. Treatments should deal with this.

Riverside

- Parolees have taken advantage of AB 109 since the most time they can serve for a violation of parole is 90 days. Gang members are using this mandate to get back into the jails and conduct gang activity. Since October 2011, the state mandate has caused and allowed convicts to be re-released at least six times from county jail.
- > Since October 2011, 2,200 prisoners have been released, but this amount is slightly above the state's projections.
- ▶ 65% of these offenders are at high risk of reoffending, which is about 25% over the initial projection.
- > Approximately 800 need supervision as "1170" or "split sentence" offenders.

San Bernardino

- Legislation to fix the issue of 82% of offenders being given "straight time" and no supervision after release.
- > Over 3,000 have been released early and finding treatment for them is an ongoing problem because of the risk of losing funding.

Ventura

- 35% of those released have been rearrested for new offenses. Police and Probation teams have to be sure to be in constant contact with the higher risk group to prevent more crimes/victims.
- > Realignment does not subject offenders to custody for a longer time for repeat offenders. No supervision or consequences once they are released.
- > When you decrease consequences for crime, the crime rate goes up. Violent crime and property crime are on the rise.
- > Need more custodial programs to attack the N3 population and establish good transition and linkage plans prior to release and entering community.

PROBATION HAS THE MOST RESPONSIBILITY AND INADEQUATE RESOURCES

Imperial

- > Probation has been impacted because of "straight time" and "split" supervision has increased by 15% and is aggravated because of degree of offender classification. Probation has the most responsibility and inadequate resources.
- Lack of time to prepare for the offenders. Increased caseloads to probation, jail, and courts.

Los Angeles

- > County has received 1,000 individuals in one month who under previous legislation that would have been assigned to parole instead of probation.
- > Currently there are 100,000 individuals under supervision by the probation department.

Orange

> Those offenders that do not need to be in custody need more than just probation officer because of mental health and drug dependency problems.

Riverside

- > Implementation has gone as well as expected, but the County is still struggling with hiring staff to handle supervision.
- By July 2013, the County will also take on the responsibility for hearings of remaining parole population. Programs and services had to be developed.

ADVERSE EFFECTS TO PUBLIC SAFETY

Imperial

> There should not be an impulsiveness to evaluate programs that focus on public safety and treatment prematurely based on emotionally driven incidents.

Los Angeles

- Public safety is a concern because the inmates are placed on probation, but only 5% of those men will have an obligation to the Probation Department.
- The day-to-day impact is substantial because of the responsibility for the safety of the community and because Probation cannot adequately supervise.

Riverside

The people that need to be out of the community for some period of time (i.e., in prison) are not so this causes public safety concerns.

San Bernardino

These offenders all have families in our communities, and unless the issues with particular offenders are addressed, children will continue to learn criminal behaviors and eventually end up in the system. Treatment should target the population who are low-risk offenders and the potential for impact to both children and families in the community.

Ventura

> There is not just a shift in inmates, supervision, and incarceration duties, realignment reduces the consequences for committing crimes in a profound way.

OTHER ISSUES

Lawsuits

> Potential lawsuits (frivolous) over rights. They do not receive the same privileges in county jail as they do in State prison. Shorter-term inmates want more and separate privileges than long-term inmates.
